Request: Approval of architecture for a new biotechnology building with associated site improvements within the

Sunbeam PUD. Building is located within the Fishers Life Science and Innovation Park.

List Bio elevations were approved in July 2022. Plans have been updated by the Petitioner. The front elevation faces 126th St. Staff recommends approval with recommendations for façade improvements.

Karen Walker of List Bio presented the plans for the elevation. She noted that window options are limited due to product storage. Another building will hide the West elevation in 2-3 years. Materials were presented. In discussion, Megan Baumgartner noted the continued landscaping for the neighbors. Shawn Curran noted that you will still see the west side of the building, even with the new one. He is looking for offset panels with paint and glass.

Two iterations were discussed which would break up the facades. Emily Bowman and Howard Stevenson agree that the west corner is missing something.

Mr. Stevenson asked for a Motion. Ms. Baumgartner made a Motion to approve, with the condition that List continue to work with Staff on architectural improvements to the North facade, seconded by Mr. Curran. The Motion was approved, 4-0.
